as part of December's [Provisional Local Government Finance Settlement for England: 2026-2027 to 2028-2029](#), the government has made around £4.6 billion additional funding available for adult social care in 2028/29, compared to 2025/26. Adult social care funding is also being simplified - to give local government more flexibility - and redistributed to where it is needed most.

As discussed, we have also now published our new annual local authority priority-setting document '[Adult social care priorities for local authorities - GOV.UK](#)'. This publication sets out clear priority outcomes and expectations for local authorities' delivery of adult social care from 2026/27, to support local decision-making and progress towards a National Care Service.

Employment Rights Act - ACAS UPDATE - From February 2026:

- automatic unfair dismissal protection for participation in industrial action (beyond current 12-week limit)
- streamlined rules for industrial action notices, ballots, and picketing

From April 2026:

- statutory sick pay (SSP) from day one of sickness (instead of day four)
- removal of minimum earnings threshold for entitlement to SSP and several family leave payments
- extended statutory paternity leave and expanded shared parental entitlements

Late 2026 to early 2027:

- removal of the unfair dismissal compensation cap
- reduction of the qualifying period for unfair dismissal claims from two years to six months, effective 1 January 2027
- new protections covering sexual harassment, flexible working rights, protection from 'fire and rehire' practices, and extended tribunal claim time limits (increasing from 3 months to 6 months)

Consultation on New Regional CPR Guidance for Adults

The London Palliative and End of Life Care Clinical Network has developed draft regional guidance on Cardiopulmonary Resuscitation (CPR) recommendations in adults. The aim is to support the use, best practice and transferability of CPR recommendations across organisational boundaries, so they accompany a person and apply in all settings. The guidance is intended to complement, rather than replace or duplicate, existing relevant local healthcare policies and procedures.

Dr Katherine Buxton is Consultant in Palliative Medicine and Clinical Director Palliative and End of Life Strategic Clinical Network NHSE London has agreed to present the guidance, answer questions and importantly collate feedback. We know this is often a particularly emotive area of work in our field and perhaps not always well understood. Katherine will also be joined by Lynnette Kennedy Consultant Learning Disability Nurse who was part of the development group.
